1. Trust Deed

In this act trustees are bound to execute the decisions imposed following the rules. It is declared to collect Rs.500/- from every trustee. If there are any changes in the rules of the trust then the information of changes, the reason for changes etc have to be got verified, on verification they have to be implemented. After the trust deed is registered true copy of it should be brought to the notice of the trustees and has to be declared that this is the trust of rules. Trust possesses the powers to receive the amount credited from this trust in the joint account of President and Secretary. Once the amount is credited it is decided withdrawal of the amount can be done only through cheque. It is also decided not to issue cheques during lunch hours.

2. Name of the trust

3. Office of the Trust.

5. Other assets of the trust :

- a. Along with the contributions of the trustees all other movable and immovable properties in the name other trust i.e., in the joint account of the President and Secretary have to be credited in Nationalized Bank.
- b. The valuation of the trust's movable and immovable properties is to be got done, and handed over to the trust. Further, the movable and immovable properties got to the trust shall be registered in the name of the trust. All the properties of the trust as per rules legally have to be brought under the trust administration and the rules of it have to be adhered to.

6. Having taken permission from the Land Development Department purchasing of land in rural areas, converting it into layout and distribution of sites. Giving preference to schools, colleges and Health Department Rural Health Department land to be utilized.
7. Distribution of Honorarium identifying rural talented backward children.
8. To cooperate in the celebration of religious functions and festivals.
9. To organize programs necessary for members to be financially independent.

7. Trust Executive Board

- a. Trustees are the members of the trust. Every member being a life member will be a member of the Executive Board. In this trust Executive Board has the powers to select members and to look after the administrative works.
- b. The founder trustee through cooption can be appointed as the executive board member. A maximum of 5 trustees together have to be present for the meeting or if the meeting is to be held then 2/3 trustees majority should exist.
- c. Among the trustees if any has submitted resignation or if is not present in 3 consecutive meetings then secretary through registered post has to issue notice and has to bring it to the notice in the trustees meeting. Through coopt the trustees of the trust and the selected trustees can select a trustee. The said meeting should have 2/3 Korum.
- d. No trustee should suggest regarding spending of the finance or funds that is available in the trust. No criminal cases of any type should be there on the new trustees to be appointed. The socially elected trustee should be a respectable person and also be of simple living. On any of the trustee if any charges arise or if is a part of criminal case then such a person will be suspended. In the matter of removal of a trustee also Executive Board 2/3 part members should be present.

- e. The members in this trust possess power to select a trustee. In this matter keeping in view the aims and objectives of the trust can suggest.
- f. Every member being a life the member of trust should actively participate in all the meetings and they apart from possessing rights in the proceedings have rights to verify the accounts book and in regard to that have powers to submit written justification.
- g. The trust should posses register in which the members details like their name address and other details like nominees name for receiving their contribution etc should be mentioned with signature of every members.

8. The board of trustees

- a. Trustees of the trust have powers to select trustees to look after the administrative matters and administration.
- b. Once a month all the members of the trust have to attend the meeting and look after the administrative matters. Apart from members attending the meeting once a month, if necessary should also be present even in additional meetings held. In every meeting 1/3 rd part of the trustees attendance is a must.
- c. In the meeting, every trustees keeping in view the aims and objectives of the trust should execute the work.
- d. Every member of the trust possesses rights to collect contributions or resources or funds or aids to the trust.
- e. Trustees of the trust have rights to take and refund the amount of the trust and also have powers to look into the details of the amount credited to the bank.
- f. Trusties of the trust are fully independent to develop the movable and immovable properties of the trust. But they don't posses rights to sell of mortgage even in any context of the conditions. They only possess rights to give suggestions and advices.

- g. Trust possesses the powers to utilize the contributions received by the trust in any form for its renovation and Social Welfare.
- h. Trustees with complete cooperation can receive additional orders to develop any of the resources etc. for this they have to propose through proposal. The trustees in the trust possess eligibility to work as advocates, chartered accountants, teachers, lecturers, tutors, demonstrators, administrators, clerical staff, etc. Apart from this if they work elsewhere they will lose their membership. But in the trust trustees are independent to work.
- i. Trustees if they observe any illegal activities in the trust they can file case in the court or in regard to any financial matters irregularities happen then in Mysore court only the matters can be got decided and actions can be imposed.
- j. President and Chairman can be select from the trust members officially selected President or Secretary has to look after the day to day activities. In such a way selected members as per rules have right to work for a period of five years. The president and secretary holding powers every month in the trust meeting have to submit the accounts of the trust and get it approved.

9. Jurisdiction of the office:

After completion of a year as per para 61 of the trust deed all trustees possess rights to select the future president and secretary. Their period of power is limited to 5 years. In this proceedings taken decision is the final.

10. Board of trustees powers and functions'

12. Powers of the Secretary:

Trust secretary has powers to look after the accounts to arrange meetings and present the proceedings of the meeting and also has to supervise the movable and immovable of the trust. Secretary one week in advance has to bring to the notice of the trustee members about the meeting. And one month in advance for the annual meeting. In financial matters he has to render full responsibility. Meeting agenda etc have to be prepared and has powers to give suggestion and advises to the president in regard to the meeting. Secretary under his control has to have all the funds contributions and records concerned to it. In the meeting he has to present the accounts expenditure. And if there is an expenditure of more than Rs.1,000/- then prior permission from the trust is to be taken.

- In regard to the accounts of the Educational Institutions under the trust along with the president action have to be taken. Secretary possesses powers to submit the accounts of the educational Institute its work execution and its official letters correspondence.
- Secretary possesses powers to look after the Educational Institute staff and their services and to organize public functions and to meet the expenses incurred towards them.
- Secretary possesses powers to look after all the expenses incurred by the trust and to look after the resource of the trust.
- Secretary possesses powers to increase the contributions collecting from the public and receive gifts and donations. Such collected has to be deposited to the bank and if expenditure is to be done without effecting the trust resources it has to be taken up.
- Secretary possesses powers to deposit the funds of the trust and if nomination required presenting it in the meeting action can be taken. If necessary seminars etc can be conducted with collaboration of the concerned departments.
- Secretary in special cases possesses powers to arrange training, camps etc.
